Per BWID's Bylaws: BWID will provide local fire departments a water source for fighting fire in the surrounding area of Southern Wasco County. The water for fire suppression shall be taken from the BWID delivery system at no charge to the fire department. The delivery system includes fire fills, and fire hydrants for use by fire and tanker trucks that are installed and maintained at no charge to the fire department.
